SUBJECT : **AMENDMENT OF THE LIST OF APPROVED ASEAN HARMONIZED TARIFF NOMENCLATURE (AHTN) OF THE DEPARTMENT OF AGRICULTURE (DA) DEPARTMENT ORDER (DO) NO. 3 SERIES OF 2024 SYSTEM ACCREDITATION OF FOREIGN MEAT ESTABLISHMENTS (FMEs) OF BRAZIL TO EXPORT BEEF, PORK, AND POULTRY MEAT (CHICKEN, TURKEY, AND DUCK) INTO THE PHILIPPINES**

WHEREAS, the Department of Agriculture (DA) issued the DA Department Order (DO) No. 3 Series of 2024 System Accreditation of Foreign Meat Establishments (FMEs) of Brazil to Export Beef, Pork, and Poultry Meat (Chicken, Turkey, and Duck) into the Philippines;

WHEREAS, DA DO No. 3 Series of 2024 was published in one (1) newspaper of national circulation on March 25, 2024, and the effectivity date commenced on April 10, 2024;

WHEREAS, appeals from stakeholders to include the specific ASEAN Harmonized Tariff Nomenclature (AHTN) Codes for the beef, pork and chicken commodities;

WHEREAS, previous accreditation DA Administrative Circular No. 11 Series of 2018 and DA DO No. 6 Series of 2020 includes the following AHTN Code;

WHEREAS, upon review of the DA Inspection Mission (DAIM) reports, this is the final and corrected approved list of commodities and their respective AHTN codes approved for export to the Philippines:



TIU LAUREL JR., Secretary of Agriculture, by the powers vested in me by law, do hereby issue this Order granting **Amendment of the list of Approved AHTN Code** for the **System Accreditation** to the **Government of Brazil** to export **beef, pork, and poultry meat (chicken, turkey, and duck)** into the Philippines, with full compliance to existing regulations and conditions provided in the DO No. 3 Series of 2024 and its Annex hereby set forth.

This ORDER shall take effect 15 (fifteen) days after the publication in one (1) newspaper of national circulation or Official Gazette and filing of a copy at the Office National of the Administrative Registrar (ONAR) at UP Diliman, Quezon City.
