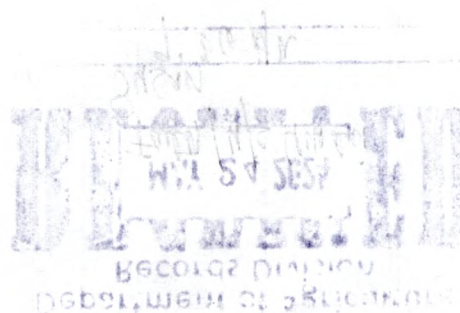
All provisions in Special Order No. 657, Series of 2024 remain in order.
