SUBJECT : AUTHORITY TO CONDUCT INTERNAL CONSULTATION WORKSHOP ON THE DRAFT IMPLEMENTING RULES AND REGULATIONS ON THE SUPERVISION, MONITORING, AND TRANSFER OF MULTI-SPECIES MARINE/FRESHWATER HATCHERIES IN THE PHILIPPINES

In the interest of service, the Bureau of Fisheries and Aquatic Resources is hereby authorized to conduct and attend the **Internal Consultation/Workshop on the Draft Implementing Rules and Regulations on the Supervision, Monitoring, and Transfer of Multi-Species Marine/Freshwater Hatcheries in the Philippines** in Quezon City on June 10 - 12, 2024.

The said activity aims to:

1. Update the draft IRR which will be presented for public consultation.
2. Gather comments/inputs from the LH Project regional focal persons;

The crafting of the Implementing Rules and Regulations of the legislated hatcheries particularly the monitoring, supervision, and turn-over/withdrawal of the facility to the LGU is in accordance with the various legislations for hatchery establishment.


