WORKSHOP ON THE DRAFT IMPLEMENTING RULES AND REGULATIONS ON THE SUPERVISION, MONITORING, AND TRANSFER OF MULTI-SPECIES MARINE/FRESHWATER

HATCHERIES IN THE PHILIPPINES

In the interest of service, the Bureau of Fisheries and Aquatic Resources is hereby authorized to conduct and attend the Internal Consultation/Workshop on the Draft Implementing Rules and Regulations on the Supervision, Monitoring, and Transfer of Multi-Species Marine/Freshwater Hatcheries in the Philippines in Quezon City on June 10 - 12, 2024.
