AUTHORITY TO CONDUCT INFORMATION CARAVAN TO PROMOTE AGRIBUSINESS AND MARKETING-RELATED SERVICES AND

INITIATIVES

In the interest of service and create awareness on agribusiness and marketing-related services and initiatives, the Agribusiness and Marketing Assistance Service (AMAS), in collaboration with the local government units (LGUs) and other concerned DA agencies, is hereby authorized to conduct a series of "Information Caravan" in the National Capital Region (NCR).
