## SUBJECT: 13TH MEETING OF THE ASEAN SEAWEED INDUSTRY CLUB (ASIC) ON ASEAN COOPERATION IN AGRICULTURE AND FOREST PRODUCTS PROMOTION SCHEME ON JULY 16-18, 2024 IN PUERTO PRINCESA CITY, PALAWAN

In the exigency of service, the Bureau of Fisheries and Aquatic Resources (BFAR) is hereby authorized to conduct the 13th Meeting of the ASEAN Seaweed Industry Club (ASIC) on ASEAN Cooperation in Agriculture and Forest Products Promotion Scheme on July 16-18, 2024 in Puerto Princesa City, Palawan.

The ASEAN will adopt joint efforts to strengthen trade promotion and negotiations on ASEAN agricultural products in order to enhance ASEAN's competitive posture, and to sustain the expansion of ASEAN agricultural exports in international markets; it shall foster cooperation and collective action in international and interregional fora as well as in international organizations and regional groupings; also it will continue to sustain relations with its dialogue partners and other producing/consuming countries towards the advancement of the commodity issues; and acknowledges that sub-regional arrangements among the Member States economies to complement overall ASEAN economic cooperation.
