2. Duties and Responsibilities

The IRMAT shall serve as the scientific and technical advisory body on insect resistance management and shall perform the following:

- Assist in the formulation of policies and regulatory initiatives relevant to management of insect/arthropod pest resistant GM crops;
- b. Assist the BPI in the review of updates and periodic reports submitted by the industry;
- c. Review proposals and results of technical studies related to IRM;
- d. Recommend new technical studies when necessary;
- e. Serve as resource persons for IRM seminars;
- f. Provide technical inputs, comments and assistance in the preparation of Information, Education Communication (IEC) materials and capacity building activities;
- g. Share information on new developments on IRM; and
- h. Report/attend meetings as called for the BPI Director.

The professional fee and expenses incurred by IRMAT in the performance of their functions shall be charged against the funds of the BPI, subject to the usual government accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force unless revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
