SUBJECT : AUTHORITY TO CONDUCT AND ATTEND THE TRAINING ON BASIC MONITORING AND EVALUATION FOR THE DEPARTMENT OF AGRICULTURE DISASTER RISK REDUCTION MANAGEMENT PERSONNEL PHASE II

In the interest of service, the Department of Agriculture - Disaster Risk Reduction and Management Section (DA DRReaMS), Field Operations Service is hereby authorized to conduct the Training on Basic Monitoring and Evaluation (M&E) for DA DRRM Personnel Phase II on July 8 - 12, 2024 in the Cagayan Valley.

This training aims to develop the updated Strategic Plan of Action for Disaster Risk Reduction in Philippine Agriculture and Fisheries. Specifically, its objectives are to provide a compendium of programs, projects, and activities (PPAs) aligned in the DRRM goals and objectives; further develop and standardize the DRRM M&E system across DA Central Office, Regional Field Offices, DA Bureaus, Attached Agencies, and Attached Corporations; formulate the evaluation plan segment of the DRRM M&E system; and explore the potential for integrating the DRRM M&E system with the current DRRM Information System (DRRMIS).
