AUTHORITY TO CONDUCT AND PARTICIPATE IN THE CONDUCT OF 20<sup>TH</sup> REGULAR SESSION OF THE SCIENTIFIC COMMITTEE OF THE WESTERN AND CENTRAL PACIFIC FISHERIES COMMISSION

In the exigency of service, the Bureau of Fisheries and Aquatic Resources-Capture Fisheries Division (BFAR-CFD) is hereby authorized to conduct the "20th Regular Session of the Scientific Committee of Western and Central Pacific Fisheries Commission" in Quezon City or vicinities as a commitment to the Western and Central Pacific Fisheries Commission being a member state. The said activity is scheduled on August 14-21, 2024.

The Scientific Committee Meeting brings together scientific experts, fisheries managers, policymakers, industry representatives, and other stakeholders to discuss and provide scientific advice on various aspects of fisheries management within the WCPFC's jurisdiction. The committee plays a crucial role in assessing fish stocks, analyzing fisheries data, evaluating the impacts of fishing activities, and developing strategies for sustainable fisheries management. The Scientific Committee's work is essential in providing objective and evidence-based advice to ensure the long-term sustainability of fisheries resources in the Western and Central Pacific Ocean.

In line with this, the following BFAR Divisions/Centers/Offices/Units and members of the fishing industry are hereby authorized to attend the said capacity-building/training:

The created Working Committee for the hosting of SC20 shall serve as the organizer, coordinator, and secretariat in the activity.
