SUBJECT : AUTHORITY TO CONDUCT AND PARTICIPATE IN THE INTEGRATED ENVIRONMENTAL AND SOCIAL SAFEGUARDS MAINSTREAMING: ROAD RIGHT OF WAY AND SITE ACQUISITION, SOCIAL AND INDIGENOUS PEOPLES ASSESSMENT, AND GRIEVANCE REDRESS MECHANISM FOR INFRASTRUCTURE AND ENTERPRISE SUBPROJECTS
