SUBJECT : AUTHORITY TO CONDUCT NATIONAL MONITORING, EVALUATION AND LEARNING (MEL) COORDINATION MEETING CUM TRAINING ON THE USE OF SIDLAN: INFRASTRUCTURE SUBPROJECTS MONITORING (I-BUILD) AND COMMODITY INVESTMENT PLAN MONITORING (I-PLAN) MODULES

In the exigency of service, the Philippine Rural Development Project (PRDP) is hereby authorized to conduct the National Monitoring, Evaluation, and Learning (MEL) Coordination Meeting cum Training on the Use of PRDP Management Information System (MIS) v2.0 or known as Sidlan, particularly its Infrastructure Subprojects Monitoring (I-BUILD) and Commodity Investment Plan Monitoring (I-PLAN) Modules, on July 23-26, 2024, in National Capital Region (NCR).

The expected output of the activity is to capacitate key personnel who are involved in utilizing the upgraded version of the PRDP MIS. The following outputs are expected at the end of the activity:


