SUBJECT : AUTHORITY TO CONDUCT AND ATTEND THE 4K PROGRAM TRAINING OF TRAINERS ON CORN AND CASSAVA FARM MANAGEMENT

In the exigency of service, the Kabuhayan at Kaunlaran ng Kababayang Katutubo-National Program Management Office (4K-NPMO) is hereby authorized to conduct and participate in the **4K PROGRAM TRAINING OF TRAINERS ON CORN AND CASSAVA FARM MANAGEMENT** on **19-23 August 2024** in Region IV-B.

This training aims to empower implementers and Indigenous Peoples (IP) partners with essential skills to support sustainable corn and cassava farming practices within Indigenous Cultural Communities. This includes promoting farming techniques sensitive to their cultural context and environment. Additionally, the objectives seek to enhance community resilience through capacity building in agriculture, share successful methods from Indigenous Peoples Organizations for thriving in markets, and foster collaborative partnerships to advance Indigenous-led agricultural initiatives.


