SUBJECT : AMENDMENT TO SPECIAL ORDER NO. 628, SERIES OF 2024 RE: AUTHORITY TO CONDUCT AND ATTEND THE ORIENTATION ON THE DA INTERNAL GUIDELINES FOR THE UPDATING OF PUBLIC INVESTMENT PROGRAM (PIP) 2023-2028 AND THE THREE-YEAR ROLLING INFRASTRUCTURE PROGRAM (TRIP) 2026-2028 AS INPUT TO THE FY 2026 BUDGET PREPARATION, AND ON THE USE OF THE DA PUBLIC INVESTMENT PROGRAM SYSTEM (DA-PIPS)

In the exigency of service, Special Order No. 628, Series of 2024, authorizing the conduct and the attendance to the *Orientation on the DA Internal Guidelines for the Updating of Public Investment Program (PIP) 2023-2028 and the Three-Year Rolling Infrastructure Program (TRIP) 2026-2028 as Input to the FY 2026 Budget Preparation, and on the Use of the DA Public Investment Program System (DA-PIPS)*, is hereby amended to change the title of the activity as “Orientation on the Internal Guidelines for the Formulation of the Investment Program for the DA’s 4-Year Plan, *Para Sa Masaganang Bagong Pilipinas* and Updating of the Public Investment Program (PIP) 2023-2028 and the Three-Year Rolling Infrastructure Program (TRIP) 2026-2028 as Input to the FY 2026 Plan and Budget Preparation, and on the Use of the DA Public Investment Program System (DA-PIPS)”.
