- 3. To ensure the timely submission of monthly reports on production data using prescribed templates;
- 4. Present updates on the trainings that ATI plans to implement to prevent duplication of intended participants; and
- 5. Present list of Organic Agriculture Program's beneficiaries to avoid multiple provisions of interventions to each target beneficiary.
