SUBJECT : AUTHORITY TO CONDUCT THE PROVINCE-LED AGRICULTURE AND FISHERIES EXTENSION SYSTEMS (PAFES) FY 2024 MID-YEAR PHYSICAL AND FINANCIAL ASSESSMENT

In the exigency of service, the Field Programs Coordination and Monitoring Division (FPCMD) is hereby authorized to conduct the Province-led Agriculture and Fisheries Extension Systems (PAFES) Physical and Financial Mid-year Assessment on July 29-August 2, 2024 in Davao City (Region XI).

The activity aims to:

1. Assess the FY 2024 mid-year physical and financial PAFES accomplishment and implementation in the provinces as well as the utilization of Php41.339 million National Rice Program funds in support to PAFES under ATI and Php 80.887 million provided to the DA- RFOs;
2. Review and update the three-year CPAFEP Plan of selected provinces based on the progress and challenges encountered in the first half of the year;
3. Identify mid-year challenges and obstacles in the implementation of PAFES and propose practical solutions to address these issues;
4. Present the ways forward of the PAFES implementation for the remaining months of the FY 2024.
