The APBPU regional coordinators shall perform the following duties and responsibilities inherent to their designation in concurrent capacity with their regular function:

- 1. Brief the DA-Regional Executive Director on the updates of animal products and by-products activities;
- 2. Assist in the formulation of appropriate planning activities at the regional level;
- 3. Prepare workplans and identify possible activities on animal products and byproducts utilization;
- 4. Coordinate/conduct and implement research and development, and training activities in the region;
- 5. Monitor and evaluate the program of activities in the region;
- 6. Submit quarterly reports to the DA-Regional Executive Director, BAI and APDS; and
- 7. Attend regular-annual consultative meeting at the Animal Products Development Center, located in Marulas, Valenzuela City.

All expenses to be incurred by the APBPU regional coordinators in the performance of their duties and responsibilities shall be chargeable against their offices' funds, subject to the existing government accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force until revoked in writing. All orders, memoranda, and other issuances inconsistent herewith are deemed revoked.
