**Certified True Copies of the following:** (2024 CTC from the agency and not from the company lawyer)

- 1) DTI or SEC registration, whichever is applicable
- 2) Certificate of Good Standing from SEC for corporations
- 3) Duly notarized sworn statement of importation
- 4) Summary of the \*SAD (Single Administrative Document) of the MAV product from previous importation
- 5) ITR or the appropriate BIR form for the latest FY
- 6) Updated Mayor's Permit
- 7) Accreditation Certificate from pertinent DA agencies
  - ✓ **Pork/Poultry** – NMIS (National Meat Inspection Service)
  - ✓ **Corn/Coffee/Potatoes** - BAI (Bureau of Animal Industry), BPI (Bureau of Plant Industry)

**New Entrants should have a proof of importation of at least: 9MT PORK and POULTRY ; 6MT POTATO; 12.5MT CORN; 6MT COFFEE.**

**MAV Application Period: November 2- 29, 2024**

**Start at 8:00 AM of November 2 until 5:00 PM of November 29, 2024**

❖ All approved online application form and requirements must be submitted using an **A4 color coded clear book with the name of your company written on the cover**. Only application submitted to and received by **MAV Secretariat staff** from 8:00 am of November 2 to 5:00pm of November 29, 2024 shall be honored.
