**SUBJECT : AUTHORITY TO CONDUCT AND PARTICIPATE IN THE UNIFIED NATIONAL ARTIFICIAL INSEMINATION PROGRAM (UNAIP) 2024 YEAR-END PROGRAM REVIEW AND ASSESSMENT**

As a livestock breeding extension program of the Department of Agriculture (DA), the Unified National Artificial Insemination Program (UNAIP) pursues to expand the government's initiative of further intensifying the institutional capability of the LGUs. It Also seeks to put in place the AI Infrastructure and mechanism that would ensure the Program's sustainability by improving the essential integrals to include the development of human resources, provision of equipment, and strengthening of institutional linkages.

In line with this, the UNAIP is hereby authorized to conduct its 2024 Year-End Program Review and Assessment on November 25-29, 2024 at Region IV-B Palawan.
