## SUBJECT : AUTHORITY TO CONDUCT AND ATTEND THE AGRO-ENTERPRISE CLUSTERING APPROACH (AECA) FACILITATORS SKILLS TRAINING

In the exigency of service and for the effective implementation of the project, the Philippine Rural Development Project (PRDP) – Enterprise Development of the National Project Coordination Office (NPCO) is hereby authorized to conduct the **Agro-Enterprise Clustering Approach (AECA) Facilitators Skills Training** on November 4-8, 2024 in Baguio City.

The activity aims to: 1. Recall and explain at least 80% key AECA concepts (measured by a knowledge review); 2. Apply and practice new facilitation skills through hands-on exercises in AECA topics demonstrated through role-playing sessions and observed by trainers; 3. Develop and submit a detailed catch-up action plan for AECA implementation with identified Farmers, Cooperatives, and Associations (FCAs) ensuring 100% completion by the end of the training; and 4. Deliver a practice training module, integrating core training principles and methodologies, with at least 80% improvement in delivery skills, as assessed through feedback and a revalida session.
