AUTHORITY TO CONDUCT AND ATTEND THE "CONSULTATION AND WORKSHOP: CRAFTING OF ACTION PLAN AND ITS STRATEGIES TO BOOST SEAWEED PRODUCTION THROUGH BFAR AND SEAWEED FARMERS"

COOPERATIVES PARTNERSHIPS" ON NOVEMBER 18-22, 2024 IN PALAWAN

In the exigency of service, the Bureau of Fisheries and Aquatic Resources (BFAR) is hereby authorized to conduct the "Consultation and Workshop: Crafting of Action Plan and its Strategies to Boost Seaweed Production through BFAR and Seaweed Farmers' Cooperatives Partnerships" on November 18-22, 2024 in Puerto Princesa City, Palawan. The objectives of the activity are to orient the participating cooperative leaders about the Enhanced Philippine Seaweeds Development Program; familiarize the participants on the Philippine Seaweed Industry Roadmap; orient the participants on the Clustering and Consolidation Strategy of the Department of Agriculture; identify areas of cooperation between EPSDP and the Cooperatives in enhancing seaweeds production and increasing farmers income; identify and overcome challenges to an effective BFAR-Cooperative Partnership in attaining seaweed value chain; develop a Cooperatives-driven Seaweed Work and Financial Plan and devise strategies to achieve it; and intensify organizing of more seaweed farmer cooperatives.
