

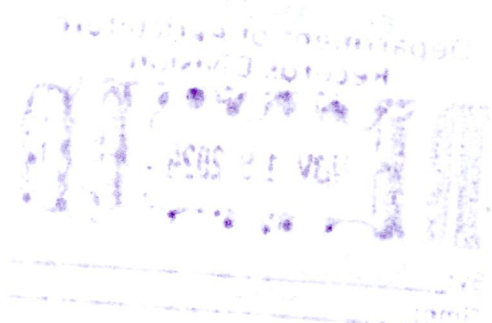
This Order shall take effect immediately and shall be considered revoked upon completion of the event. All orders and issuances inconsistent herewith are deemed revoked.
