XIII. DA/LOCAL SECRETARIAT

The local secretariat shall have the following additional tasks:

- 1. **Registration**: This includes setting up a registration desk where attendees can check in and receive their conference materials. This will also include welcoming attendees, providing them with name badges, and distributing conference materials such as agendas and schedules.
