AUTHORITY TO CONDUCT AND PARTICIPATE IN THE LUZON CLUSTER A ORIENTATION/REORIENTATION, ASSESSMENT, AND WORKSHOP FOR THE IMPLEMENTATION OF THE FARMERS AND FISHERFOLK ENTERPRISE DEVELOPMENT PROGRAM UNDER REPUBLIC ACT NO. 11321 OR THE

"SAGIP SAKA ACT"

In the interest of service, the Office of the Assistant Secretary for High-Value Crops, Sagip Saka and Intellectual Property, in coordination with the Agribusiness and Marketing Assistance Service (AMAS), is hereby authorized to conduct and participate in the Luzon Cluster A Orientation/Reorientation, Assessment, and Workshop for the Implementation of the Farmers and Fisherfolk Enterprise Development Program (FFEDP) established under Republic Act (R.A.) No. 11321 or the "Sagip Saka Act", in Region I from December 9-13, 2024.

The activity aims to orient/reorient and provide the identified Department of Agriculture (DA) Implementing Units and Offices in Regions I, II, III, and CAR a comprehensive overview of the law and its Implementing Rules and Regulations (IRR), its implementation framework, and process flow, at both the national and regional levels. Additionally, it seeks to identify existing programs and projects related to agricultural and fishery enterprise development, identify issues and concerns in the implementation of the Program, recommend strategies and action plans to address these concerns, delineate the functions and responsibilities of each concerned implementing unit/office, and harmonize existing programs to align with the provisions of the law and its IRR.
