Expenses to be incurred in the activity such as food, venue, accommodation, supplies and materials, and other incidental expenses shall be charged against the 4K-NPMO funds, which also include the participation of representatives from Indigenous People Organization (IPO) in each Region. Traveling expense, per diem, and other incidental expenses for other participants excluding the IP representatives shall be chargeable against the fund of their respective offices, subject to existing government accounting and auditing rules and regulations.

All other provisions stated in Special Order No. 1467, Series of 2024, shall remain the same.

This Order shall take effect immediately and shall remain in force until the completion of the activity. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
