#### **Overview of the Philippine Livestock and Poultry Subsectors**

Mandated to promote agricultural development in the Philippines, the Department of Agriculture (DA) has been dedicating its resources towards the boosting of local food production, the empowerment of Filipino farmers and fisherfolk, and the attainment of food security nationwide. In 2023, the Philippine Statistics Authority (PSA) reported that the country's Gross Domestic Product (GDP) was at P24.32 trillion at current prices, with the agriculture sector displaying a 1.2 percent growth rate and contributing 8.6 percent to the total national GDP.

Playing a crucial role in agricultural and economic development is the Philippine livestock and poultry industry. Faced with the devastating impacts of the COVID-19 pandemic, outbreak of animal diseases, international conflicts, inflation, and agricultural smuggling in recent years, the industry has been focusing its efforts towards recovery.

# DA-NATIONAL LIVESTOCK PROGRAM (NLP)

By virtue of the Presidential Decree No. 914, series of 1976, the Livestock Development Council (LDC) was established as the DA's policy-making body for the livestock and poultry industries. After a series of reorganizations, the National Livestock Program (NLP) rose to become one of the DA's banner programs that is committed to pursue the development of the livestock and poultry subsectors in the Philippines.

The DA-NLP is headed by its Program Director and also reports to the Office of the DA Undersecretary for Livestock. It currently comprises five DA livestock attached agencies, namely, the Bureau of Animal Industry (BAI), the National Dairy Authority (NDA), the National Meat Inspection Service (NMIS), the Philippine Carabao Center (PCC), and the Agricultural Training Institute (ATI).

### **VISION**

A meat-, egg-, and milk-secured and resilient Philippines anchored on a vibrant, robust, and globally competitive livestock and poultry industry and prosperous farmers.

### **MISSION**

The National Livestock Program (NLP), a cohesive group of government agencies and field offices, shall serve as the driver and catalyst for the accelerated growth and sustainable development of the livestock and poultry subsectors through the formulation of comprehensive policy, preparation of plans, and implementation of programs, projects, and activities in consultation and partnership with the private sector and other stakeholders along the value chain.

Integrated National Swine Production Initiatives for Recovery and Expansion (INSPIRE) Program: focuses on the recovery and repopulation of the Philippine hog industry—especially in the time of the African Swine Fever (ASF) outbreak—through calibrated repopulation, establishment of production and multiplier farms and Artificial Insemination (AI) sa Barangay Centers, enhanced insurance program, and access to credit facilities and loan programs.

**Livestock Economic Enterprise Development (LEED):** distributes multiplier farm modules and provides technical and production support to clustered backyard and smallholder farmers in order to improve their production, encourage them to valueadd, and help elevate them into enterprise level.

**National Animal Genetic Resources Improvement Program:** ensures the effective conduct of the Unified Artificial Insemination Program (UNAIP) and the Philippine Native Animal Development (PNAD) to improve the country's genetic resources as well as the performance, adaptability, and productivity of the Philippine livestock and poultry sectors.

**Development and Rehabilitation/Upgrading of Government Stock Farms:** supports the operation and maintenance of livestock farms and stations under the care of the DA-Regional Field Offices (RFOs) and the DA-Bureau of Animal Industry (BAI), which will serve as nucleus or multiplier farms that produce animals for distribution and research purposes.



**Technical Support Services:** conducts trainings and other capacity-building activities, information dissemination, technology demonstrations and learning sites development, awards and recognitions, and extension incentivization.

Philippine Animal Industry Management Information System (PHILAIMIS): serves as a repository of accurate, reliable, and verified data from various DA livestock offices in order to enable effective planning, quick decision-making, and efficient service geared towards the development of the Philippine livestock and poultry subsectors.

**Other Support Services:** provides veterinary drugs and biologics, policies, capability-building activities, information dissemination, and other initiatives to promote animal health and to prevent and control the spread of animal diseases in the country.



## How to Avail of the DA-NLP's Programs and Services

**STEP 1:** Prepare a letter addressed to the DA-NLP Director stating the actual request and the location of the requesting farm, association, or cooperative.

**STEP 2:** Send your Letter of Intent along with organizational documents at livestock@mail.da.gov.ph or mail to the DA-National Livestock Program, 4/F New Building, Department of Agriculture, Elliptical Road, Diliman, Quezon City 1100.

STEP 3: The request shall undergo review for possible funding.

**STEP 4:** The DA-NLP Liaison Officer shall facilitate an endorsement letter for the evaluation and validation of the said request for livelihood and funding assistance received from various legislators, farmers' cooperatives and associations (FCAs), state universities and colleges (SUCs), and DA offices to the concerned DA-Regional Field Offices (RFOs).









#### JED B. VALENCIA Owner, EVG Farm Lipa City, Batangas

Falling victim to the ASF outbreak in 2019, Jed Valencia sought technical assistance from the DA-NLP and the Lipa City Veterinary Office (CVO). His strict implementation of biosecurity measures and other best practices was recognized by the DA, which granted EVG Farm with a Biosecurity Level 2 status in 2022 and tapped Valencia as a farm-cooperator under the INSPIRE Program.



# LIVESTOCK ATTACHED AGENCIES





Institutionalized on January 1, 1930 as per Republic Act No. 3639, the Bureau of Animal Industry (BAI) was placed under the then Department of Agriculture and Natural Resources (DANR) to investigate, study, and report animal pests and diseases, to formulate preventive measures, and to promote the development of the Philippine livestock industries.

Now an attached bureau of the Department of Agriculture (DA), the DA-BAI continues to play a vital role in the formulation of policies, programs, and projects that will effectively boost and bring prosperity to the livestock and poultry subsectors.

**Beekeeping Development Program:** promotes the development of the beekeeping industry through the development of the Philippine Apiculture Roadmap and the formulation and enforcement of food safety standards and regulations, among others.

**Contagious Bovine Pleuropneumonia (CBPP) Surveillance:** the first CBPP prevalence study in the Philippines, which formed part of the government's initiatives to apply as a CBPP-free country at the World Organisation for Animal Health (WOAH).

**Philippine Native Animal Development (PNAD) Program:** focuses on the genetic conservation, improvement, and use of Philippine native chicken, Itik-Pinas, native pig, native goat, and native cattle to generate more livelihood and income.

**Multiplier Breeder Loan Program:** helps increase the quantity and quality of the beef cattle, poultry, swine, and small ruminant populations in the country and provides production support to industry stakeholders.

**Unified National Artificial Insemination Program (UNAIP):** provides the strategic direction in the current artificial insemination (AI) efforts for cattle and carabao production, in support to the DA's livestock genetic improvement agenda and harmonizes all national livestock agencies in carrying out efficient and effective livestock breeding programs using AI technology.

African Horse Sickness (AHS) Surveillance and Reconfirmation of Freedom: one of the strategies of the government to be declared AHS-free status by the WOAH.



Peste des petits ruminants (PPR), Lumpy Skin Disease (LSD), Brucellosis: reconfirmation of freedom from PPR and LSD as well as the conduct of online trainings, technical presentations, and disease situation updates and discussions in partnership with the WOAH.

**Food Safety:** enforces and strengthens the country's food safety regulatory system—specifically focusing on food derived from animals—in compliance to the Republic Act 10611 or Food Safety Act of 2013.

**Cold Examination Facility Agriculture (CEFA):** an ongoing project that will serve as a first-border inspection facility for imported agri-fishery commodities.

National African Swine Fever Prevention and Control Program (NASFPCP): partners with LGUs to ensure implementation of the Bantay ASF sa Barangay (BABay ASF) and other initiatives related to ASF surveillance, prevention, and awareness.

**Avian Influenza Protection Program:** partners with LGUs to ensure the implementation of surveillance, disease monitoring, and other activities to prevent the spread of Avian Influenza.

**Electronic Services:** includes accreditation of importers and exporters of animals and animal products, licensing of feed establishments, registration of feed products, issuance of sanitary and phytosanitary import clearances, and more.








#### LUISA A. VELASCO Prados Verdes Farm Nasugbu, Batangas

#### **MAJOR PROGRAM**

The Dairy Industry Development Program (Overall Program): aims to accelerate the development and growth of the Philippine dairy industry through policy direction, program coordination, and implementation towards the enhanced growth and competitiveness of the industry with the end in view of achieving adequate supply of safe, quality milk and milk products contributing to food security, providing livelihood opportunities and thereby increasing incomes of small rural-based dairy farmers and proper nutrition for local consumers.





#### **SUB-PROGRAMS**

**Dairy Herd Build-Up Program:** increases local milk production and dairy stocks through the importation and purchase of local born dairy animals, breeding by artificial insemination, upgrading of local animals into dairy breed, application of technologies, and provision of credit facilities and animal health and nutrition services.

**Dairy Enterprise Development Program:** ensures the marketability of locally produced milk and the viability and sustainability of local dairy enterprises by infusing enterprise orientation among dairy producers.

**Milk Feeding Program:** provides milk to community and school-based children at risk of malnutrition as well as the elderly, pregnant women, and lactating mothers at a feeding period of 120/200 days in collaboration with local dairy cooperatives and producers.

**Dairy Regulatory Program:** strengthens the country's dairy safety regulatory system to protect consumers from unsafe and adulterated locally-produced milk, enhance industry and consumer confidence in the dairy regulatory system, achieve economic growth and development by promoting fair trade practices and sound regulatory foundation for domestic distribution, and upgrade the capability of local dairy farmers, consumers, and dairy personnel in ensuring dairy safety.

#### **BABY KRISTINE PANALIGAN-HASEGAWA**

Owner, Baby Kristine Hasegawa Dairy Farm Sariaya, Quezon

Baby Kristine Panaligan-Hasegawa received animal health services, agricultural equipment and machineries, capacity-building opportunities, market assistance, and credit services from the DA-NDA. These helped boost her farm's production to at most 50 liters of cow's milk daily, making it the top producer of raw milk within the Palcon Dairy Multipurpose Cooperative, the highest dairy-producing cooperative in Southern Luzon. She also received the Excellent Performance in Ruminant Farm (Small-Scale Category) award during the Livestock Philippines Recognition in 2023.



# DA-NATIONAL MEAT INSPECTION SERVICE

The National Meat Inspection Service (NMIS) is a specialized regulatory agency attached to the Department of Agriculture (DA) that serves as the country's sole national controlling and competent authority on all matters pertaining to meat inspection and hygiene both for locally produced and imported meat. It was created under Presidential Decree No. 7 as National Meat Inspection Commission and renamed as National Meat Inspection Service under the Republic Act No. 9296, otherwise known as the Meat Inspection Code of the Philippines, as amended by the Republic Act No. 10536.

The DA-NMIS is tasked to formulate, promulgate, and implement laws, policies, programs, and projects governing the post-harvest flow of meat to protect the interest and welfare of consumers and to promote the development of the livestock and meat industry.





Accreditation and Registration: facilitates the registration and licensing of meat establishments, rendering facilities, and meat transport vehicles, as well as the certification to ascertain compliance to national standards

**Laboratory Testing and Analysis:** provides analytical services to detect physical, biological, and chemical contaminants in meat and meat products.

**License to Import:** evaluates, verifies, and inspects meat establishments and documentary requirements of applicants.

**Meat Standard Development and Consumer Protection:** provides meat safety training to LGUs and assists customers on the resolution of related complaints.

(GMP) and Sanitation Operating Procedures (SSOP) Program: primary programs that have to be practiced in all accredited meat establishments and

(HACCP) Program: an internationally recognized system which is science-based and systematic and identifies hazards and measures for their control to ensure food safety.

Establishment Improvement Program (MEIP): provides technical and financial assistance to LGUs in upgrading their slaughter facilities to "AA" accreditation standards.



**Genetic Improvement:** oversees the gene pool for Philippine Swamp Buffalo, in situ conservation and propagation of Native Carabaos, gene pool for Riverine Buffalo, and intensified upgrading of carabaos to conserve existing local germplasm.

**Enterprise Development:** maximizes productivity and profitability in the Philippine carabao industry through cooperative development, market development, access to credit, and training of technicians and farmers.

**Research for Development:** focuses on breeding and genetics, biotechnology, nutrition and forage/pasture, animal health, reproductive physiology, management, product development, socio-economics, and policy.

**Artificial Insemination:** trains Village-based Artificial Insemination Technicians (VBAITs) to provide artificial insemination services in the community with a fee.

**Bull Entrustment Program:** loans out purebred dairy-type bulls to qualified farmers for natural mating in areas where artificial insemination services are limited and not readily available.

**Frozen Buffalo Semen Distribution:** produces and processes frozen semen from genetically superior sires or bulls for artificial insemination.

**Provision of Superior Breeding Animals:** provided only on a case-to-case and "first come, first served" basis.

**Dairy Buffalo Module:** entrusts purebred dairy buffaloes to qualified farmer-trustees, families, company, corporation, cooperative, or entrepreneurs through either modified paiwi or the Dairy Buffalo Multiplier Farm (DBMF) scheme.

**Technical Assistance and Extension:** provides free technical assistance related to animal reproduction, animal nutrition, animal health, forage production and improved feeding system, cooperative development, and dairy production and processing.

**Analysis of Milk Samples:** provides service for analysis of milk components mainly for dairy herds participating in milk recording and performance testing.

**Nutrition Laboratory Services:** assesses the nutritive value of feedstuffs and other related samples to address nutritional problems and nutrient deficiencies of livestock.

**Biosafety and Environment Laboratory:** helps maintain a disease-free environment and conducts collaborative researches and related assistance.

**Molecular Genetics Laboratory:** provides genetic testing services for livestock such as screening for genetic defects, parentage verification, traceability and identification of individual animals carrying favorable alleles of genes for production traits.

**Reproduction and Physiology Laboratory:** provides production support services such as ovarian examination, fixed time artificial insemination (FTAI), pregnancy diagnosis via ultrasound and pregnancy associated glycoproteins (lab test), semen analysis, gamete and embryo cryopreservation.

**Product Development and Innovation Laboratory:** focuses on the research, development, and innovation of milk and other carabao-based products for market promotions and development of sustainable livelihood opportunities for the dairy farming communities.

**National Livestock Cryobank Facility:** supports research for development works on ex-situ cryoconservation of animal genetic resources from diverse livestock species and provides research that are available to farmers, livestock breeders, and other clients seeking quality animal genetics in support of the animal production system.

**Information and Visitors Assistance:** disseminates relevant knowledge products and information about its programs and services using various media.

**Marketing Assistance:** assists on the establishment of dairy farming businesses and other related enterprises, branding, capacity-building, data provision, consultations, and other services.
