CREATION OF AN ADVISORY TEAM AND NATIONAL ASSESSMENT TEAM

FOR THE ASSESSMENT OF THE RICE PROCESSING CENTER (RPC)

In the exigency of service and to ensure the effective and efficient implementation of the Rice Processing Centers (RPCs) of the National Rice Program (NRP), an Advisory Team and National Assessment Team are hereby created.

In general, the Team shall conduct a nationwide assessment and evaluation on the performance and operationalization of the RPCs implemented by the NRP from 2012 to 2021 and provide recommendations to enhance the implementation of the RPCs.

- 4. NFA post harvest management, storage requirements, capacity, and efficiency support the national food security

### Duties and responsibilities:

- 1. The Team Leader will provide overall guidance and direction for the assessment process, ensuring all activities align with established protocols and timeliness as well as for the approval of the final assessment report which will be submitted to the Secretary;
- The Assistant Team Leader will provide support to the Team Leader in managing the assessment activities, assume leadership duties when the Team leader is unavailable, oversee coordination between sub-teams to ensure timely task completion, and facilitate

communication between the Advisory Team and the Assessment Team Members; and

3. The Assessment Team shall conduct the actual assessment of the existing implemented RPCs in the regions by gathering primary and secondary data from November 2024 to February 2025. They shall prepare the regional reports and have these reviewed by the DA-RFOs through its Regional Executive Director prior to its finalization.

# Duties and responsibilities:

- Provide administrative support to the Advisory and National Assessment Team, organize
  meetings, document highlights of the meeting, prepare communications, coordinate and
  disseminate highlights of the meeting, schedule, notice of meetings, and reports, prepare
  logistics for site visits, meetings, and other activities and perform coordination work with
  concerned offices; and
- Consolidate regional reports for the review of the National Assessment Team and consequently, endorsement to the Advisory Team for the finalization of the report for the approval of the Secretary.

All offices involved in RPC implementation shall extend technical and logistical support in the conduct of assessment activities in the regions.

Traveling expenses and per diem for DA Team Members shall be charged to their respective offices, while those for Regional Agricultural and Fishery Council (RAFC) representatives shall be charged to BAFE funds, subject to existing government accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force until revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
