#### ECT : CREATION AND COMPOSITION OF THE TECHNICAL WORKING GROUPS (TWG) FOR THE DEVELOPMENT OF ADDITIONAL PHILIPPINE NATIONAL STANDARDS (PNS) FOR AGRICULTURAL AND FISHERY PRODUCTS AND MACHINERY

The Bureau of Agricultural and Fisheries Standards (BAFS) is mandated to develop and promote standards to ensure food safety, quality, workers' health and welfare, environmental management, and global competitiveness of the country's agriculture and fishery products.
