SUBJECT: AUTHORITY TO CONDUCT THE PRDP YEAR-END NATIONAL PROJECT COORDINATION OFFICE (NPCO) NATIONAL COORDINATION MEETING AND ASSESSMENT

In the exigency of service and for the effective implementation of the project, the Philippine Rural Development Project (PRDP) is hereby authorized to conduct its PRDP Year-End National Project Coordination Office (NPCO) National Coordination Meeting and Assessment on December 17-18, 2024 in Region IV-A (Cavite).

As part of the continued monitoring of the implementation of PRDP Second Additional Financing (AF-2) and PRDP Scale-Up, periodic assessments are conducted to evaluate progress, address emerging concerns, and establish actionable steps for timely project delivery.
