AUTHORITY TO CONDUCT THE WORKSHOP ON UPDATING THE

DISASTER RISK REDUCTION MANAGEMENT IN AGRICULTURE AND

FISHERIES OPERATIONS MANUAL

In the interest of service, the Department of Agriculture - Disaster Risk Reduction and Management Section (DA DRReaMS), Field Operations Service is hereby authorized to conduct the Workshop on the updating of the Disaster Risk Reduction and Management in Agriculture and Fisheries Operations Manual on March 3 - 7, 2025 in the region of Central Luzon.

The primary objective of this activity is to update and improve the existing Disaster Risk Reduction and Management Operations Manual of the Department of Agriculture. Additionally, it aims to: (1) Review the existing guidelines and protocols provided in the DA DRRM Operations Manual; (2) Provide an updated list of interventions per hazard, per commodity, and per thematic pillar; (3) Provide the list of hazards, its vulnerabilities, and risks to be managed, and the approaches and strategies to be applied in reducing risks; and (4) Develop guidelines and protocols per calamity.
