**SUBJECT: AUTHORITY TO CONDUCT AND PARTICIPATE ON THE TECHNICAL WORKING (TWG) MEETING: DISCUSSION AND EVALUATION ON THE TECHNICAL PROPOSAL FOR THE DEPARTMENT OF AGRICULTURE COMMAND CENTER UNDER IB NO. 069-24 ON JANUARY 17, 20-23, 2025 IN NCR**
