AUTHORITY TO CONDUCT AND PARTICIPATE IN THE TRAINING-WORKSHOP ON THE ATTRIBUTION OF THE DEPARTMENT OF AGRICULTURE - SPECIAL AREA FOR AGRICULTURAL DEVELOPMENT (DA-SAAD) PROGRAM - PHASE 2 TO GENDER AND DEVELOPMENT (GAD) USING THE HARMONIZED GENDER AND DEVELOPMENT **GUIDELINES (HGDG)**

In the interest of service, the SAAD Program - Phase 2 is hereby authorized to conduct the Training-Workshop on the Attribution of the Department of Agriculture - Special Area for Agricultural Development (DA-SAAD) Program - Phase 2 to Gender and Development (GAD) using the Harmonized Gender and Development Guidelines (HGDG) on 26-30 May 2025 at Region IX.

The activity is in support of RA 9710 or the Magna Carta of Women as well as for SAAD to adopt gender mainstreaming as a strategy to promote and fulfill women's human rights and eliminate gender discrimination in its systems, structures, policies, program processes and procedure. Moreover, this activity aims to orient and improve participants' awareness and grasp of basic gender and development concepts, as well as to evaluate the SAAD Program Phase 2 utilizing HGDG. Specially, it aims to:

- 1) Understand the fundamental concepts, mandates, and frameworks on GAD;
- 2) Facilitate participants on acquiring knowledge regarding social relations of gender analysis;
- 3) Train participants on how to properly complete the HGDG checklists;
- 4) Equip the participants with the necessary tools to formulate the SAAD GAD activity proposals and narrative/accomplishment reports; and
- 5) Serve as critical groundwork for the GAD Planning and Budgeting thereafter.

The training shall focus on capacitating the personnel of SAAD staff from the National Program Management Office (NPMO) and Regional Program Management Support Offices (RPSMOs) to assist SAAD beneficiaries in understanding and being aware of their gender roles, ensuring the success of their SAAD projects, which will be more gender-inclusive and responsive.
