## SUBJECT: AUTHORITY TO CONDUCT THE TRAINING-WORKSHOP ON THE FISHERIES PRICE MONITORING PROTOCOLS AND PROCEDURES, AND DETERMINATION OF PREVAILING PRICES OF TOP FISHERY COMMODITIES FOR THE REGIONAL PRICE MONITORING (PM) IMPLEMENTERS (MINDANAO CLUSTER)

In the exigency of service, Fisheries Industry Development and Support Services Division (FIDSSD) of the Bureau of Fisheries and Aquatic Resources (BFAR), is hereby authorized to conduct the **"Training-Workshop on the Fisheries Price Monitoring Protocols and Procedures, and Determination of Prevailing Prices of Top Fishery Commodities for the Regional Price Monitoring (PM) Implementers (Mindanao Cluster)" on April 1-4, 2025 in Davao City (inclusive of travel time).** 

The activity aims to:

- 1. Re-orient and retool the participants on the generation of price monitoring reports and capability of employing the determination of prevailing price;
- 2. Enable the participants to be efficient in improving and standardizing the submission of PMR nationwide; and
- 3. Integrate the updates on the determination of prevailing price in preparation for the continuing development of the Electronic Fisheries Price Monitoring System (eFPMS) to eventually automate the data generation and provide close-to-real-time reporting.
