SUBJECT : AUTHORITY TO CONDUCT AND ATTEND THE FIRST QUARTER ASSESSMENT OF DISASTER RISK REDUCTION AND MANAGEMENT-RELATED PROGRAMS, PROJECTS, AND ACTIVITIES AND PLANNING WORKSHOP

In the interest of service, the Department of Agriculture - Disaster Risk Reduction and Management Section (DA DRReaMS), Field Operations Service is hereby authorized to conduct the First Quarter Assessment of Disaster Risk Reduction and Management (DRRM) related Programs, Projects, and Activities (PPAs) and Planning Workshop on April 7 to 11, 2025 in MIMAROPA Region.
