As such, they shall facilitate the day-to-day operation of the service/units in a concurrent capacity with their regular functions, duties, and responsibilities. The OIC of the service and units are authorized to sign/initial Accomplishment Reports, Certificates of Job Acceptance, and Daily Time Records.

They shall be entitled to RATA subject to DBM National Budget Circular No. 593, Series of 2024 and other issuances, traveling expenses, per diems and incidental expenses in the performance of their functions, duties, and responsibilities in view of their designations, chargeable against DA-PRS funds or other funding sources, subject to existing accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force until revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
