The DA delegation shall have the following major functions:

- 1. Actively participate and provide technical inputs or technical-secretariat support to the assigned TWG; and,
- 2. Submit technical report on the outcomes of the negotiations of their respective TWG following the prescribed format/template.
- 3. Consolidate the technical report and submit to PRS as lead agency.

The PRS shall lead the DA delegation and coordinate closely with the Department of Trade and Industry (DTI) and other concerned government agencies in preparing the Philippine position and negotiation strategies.

All expenses related to transportation, accommodation, per diem, and other necessary expenses shall be charged against available funds of their respective offices, pursuant to Item II (4) of DA Administrative Order No. 2, Series of 2019 subject to the usual government accounting and auditing rules and regulations.

This Order shall take effect immediately and remain in force until revoked in writing. All orders, memoranda, and issuances inconsistent herewith are deemed revoked.
