SUBJECT : AUTHORITY TO CONDUCT AND ATTEND THE AWARENESS AND TRAINING WORKSHOP ON CLIMATE INFORMATION SERVICES (CIS) AND CLIMATE RESILIENT AGRICULTURE (CRA) PRACTICES

In the interest of service, the Department of Agriculture - Field Operations Service is hereby authorized to conduct the Awareness and Training Workshop on Climate Information Services and Climate-Resilient Agriculture Practices of the Green Climate Fund - Adapting Philippine Agriculture to Climate Change (GCF-APA) Project on 21-25 April 2025 in Region V.

This workshop aims to enhance the understanding and application of climate information in agricultural decision-making. Specifically, the training aims to:

- 1. Assess the knowledge and skills of the participants on the climate information and existing climate products and services of DOST-PAGASA and agroclimatic advisories of DA;
- 2. Provide background information on the new climate products, services, tools and methods;
- 3. Develop participants' skills in understanding the range of forecasts and climate monitoring products of DOST-PAGASA, downscaling or learning techniques to localize and generate agrometeorological advisories;
- 4. Understand effective communication mechanisms to communicate the localized agrometeorological services; and
- 5. Conduct workshop activities to generate, localize, and communicate agrometeorology advisories.
